### The Investigation

On August 2<sup>nd</sup>, 2008, we arrived at the client's home at approximately 8:30pm. When we arrived, the client Christina met us and spoke to us in the garage area. She explained the unusual occurrences she felt she was having with images appearing in her bedroom furniture and the driveway area. She explained other areas of concern to her and gave Troy, Carol and Mike a walk-through of her home.

During the walk-through, she showed us where she had the furniture image issues; she discussed the visions that appeared to her from the rear yard and about physical activity that she witnessed that occurred in her bedroom (i.e. a candle falling and hitting her). She also supplied a drawing of a male figure she indicated was seen by her son. We noted all of her claims and issues and vowed to check them all before we left that night. Christina had an abundance of photo evidence that she wanted us to see so we downloaded her photos for analysis to be done during our evidence review.

We began our set-up at approximately 9:30pm and began our investigation at 11:20pm. We placed infrared cameras and audio throughout the home (see the diagrams for their placement). We used handheld video cameras, a thermal camera and digital cameras. We also placed two Trifield EMF detectors in the home, one upstairs and one downstairs. (Trifield meters read levels of electromagnetic fields and have the ability to decipher if they are from a natural source or not based on it's setting. The benefit to the use of the Trifield is that it has an audible tone that activates when a it's reading a notable field, thus being able to alert us when it occurs)

We brought more investigators than we normally do because of the reported activity; we wanted to have all areas of the home covered at one time. At our Command Center, which was located just in front of the front door, Darlene

manned the station and watched all of the streaming video and listened to live audio that was set up both upstairs and downstairs. The remainder of the team split up into four groups and covered the garage, the master bedroom, the living room and upstairs loft area to start. After approximately an hour, each team rotated and covered the boy's room and the office. All areas of the upper and lower floors were covered and the rear yard was examined for anything out of the ordinary.

The evening was pretty quiet. However there were two unusual events that occurred and were verified during evidence review. One was when Mike and Ryan were turning out all of the lights in the loft area at the start of the investigation. Ryan turned off the ceiling fan and when he did, the touchier lamp turned on by itself. H.B. being our electronics expert checked the lamp out and didn't find anything unusual about it except for the fact that the lamp was "touch activated". It was noted that no one was in the area of this lamp when this occurred and he couldn't find a natural reason for this to have occurred. We asked for it to happen again and it did not.

The other event occurred while Shannon was listening to the live audio at the command center towards the end of the evening. She thought she heard a woman's voice say "yes". When this occurred, she asked out loud to the rest of the team if anyone said anything just then and the team replied "no". Later during evidence review it would be determined that the voice was caught on audio from the live microphone and from two handheld recorders team members were carrying.

In the master bedroom, we checked out the areas Christina had issue with. There were markings on her mirror that she felt were of a Native American Indian in a headdress with five arrows over its head. While markings of this kind are unusual in a mirror as new as it is, there isn't any evidence that was created by anything paranormal. The image was not distinguishable as a Native American Indian to the team, however Christina was adamant that to her it did. We could not explain how this occurred. It is suggested that she have a mirror/glass professional look at it.

In the master bedroom closet we noticed an area in the far right corner of the closet that was sanded down and etched with the sign of the cross. Christina felt that she saw an image in the orange peel texture of her wall, so she sanded it down and carved the sign of the cross into it. It was not possible to determine what she saw there as she sanded it away.

Christina indicated she saw images in several pieces of wood furniture in her home. She was so affected by them that she painted several coats of paint to remove them from sight. Wood grain is a porous surface and will absorb stain or paint and can give a random image due to the grain. We examined all of the wood items and did not notice anything unusual. Wood staining she showed us from her photos was indicative of moisture staining and did not appear to be anything paranormal.

Christina also claimed to see images in the fabric of the pillow on her bed. She took the pillow out from the shell, but nothing unusual was noted.

We continuously investigated all areas of the home, asking questions, listening and even attempted to provoke a response from anything “dark”, but nothing happened. We did this until about 2:15am when Christina returned home. At that time, it was felt that we obtained all of the evidence we could, so we shut down the investigation.

## The Evidence

### **PHOTOS:**

We reviewed all of the team’s photos and Christina’s photos also. It was noted that a lot of her photos were taken close-up and were very blurry, however the team and the team’s professional photographer analyzed every photo. There was no evidence of anything unusual and the conclusion was that Christina is “matrixing” images. {See the article supplied in the evidence packet from T.A.P.S. (aka Ghost Hunters) on matrixing}.

Christina is obsessed with the idea that spirits are “imprinting” their image on items in her home. A true imprint from a spirit is made up of it’s own substance. They do not appear from everyday items or substances.

### **VIDEO:**

All video was reviewed and nothing unusual was captured. Christina made a comment that she felt one reason we didn’t catch anything was because the blinds in her bedroom were closed. Spirit’s have the ability to penetrate anything. This would not have been a reason for the lack of activity at the home.

### **AUDIO:**

All audio was reviewed and there were several EVP’s (Electronic Voice Phenomenon – spirit voices caught on a recording device that cannot be heard by the human ear) captured from the following areas:

Kitchen  
Master Bedroom  
Master Bedroom Closet  
Command Center (Near front door)  
Loft  
Downstairs Living/Dining Room

The EVP’s obtained are enclosed on the included evidence CD. EVP logs are also provided to give you a little information as to where they were caught. You will need to use a good set of headphones to hear some of them. The EVP should be positioned near the middle of the audio clip. Most of them sound like a loud whisper – some louder than others.

## The Conclusion

Based on the interview with the owner, and the evidence obtained, it is clear that there *is* paranormal activity at this location. However based on the lack of any real physical activity, it is our conclusion that this location is not considered

“haunted”. By our determining that this location isn’t haunted, doesn’t mean that this may not be the case, there just wasn’t anything obtained by us at the time we were there to substantiate this claim.

At this time, there isn’t anything to suggest that the owner, or the occupants are in danger or have anything to fear by what exists in this home.

## The Recommendations

Nothing specific at this time. Christina is encouraged to relax and except what the scientific evidence shows and to not get worked up over it. It is not an uncommon occurrence. The evidence suggests that there is nothing more than human spirits that exist in this home. This means that they are really not much different from a living person as they were in fact at one time living; they are just no longer in a physical form. Nothing was caught in our evidence to suggest anything Native American exists in the home – at least nothing obtained by us at the time of our investigation. Christina is encouraged to also except the evidence of the boundary lines on the Native American land that she obtained from the city/county and not assume that they’re inaccurate.

Should she want to investigate on her own, she is welcome to submit to us her recordings for analysis. She should also research on her own the subject matter of “matrixing” and read about it. Should she still feel differently about her photos, she should submit them to other paranormal groups for their analysis for a second opinion. Many groups offer free analysis, so she should check into that.

The above report was prepared under a collaborative conclusion of the outcome in this case. It contains a true and accurate account of the investigation and the evidence obtained.

## Personal Experience

### **Shannon’s Personal Experience/Corona Case/August 2nd, 2008**

Early in the investigation, Omar and I were upstairs in the loft. We had been asking some questions for about 20 minutes when Darlene said the live audio was acting up. I then went to the boy’s room and told Troy to go see what’s up. Omar and I asked a couple more questions and I was also stating that there was a lot of noise going on downstairs. Omar asked "Are there too many people in the house for you?" A couple seconds later, I heard a female voice say "yes." I asked Omar if he heard it too and he did as well. It was not Carol in the master room because the door was closed and what we heard was too clear. We then went back to doing EVP’s after all the live audio was fixed we didn’t hear anything else.

We had no temperature changes or K2 spikes the entire time we were up there but it seems as though we might have heard a female disembodied voice say "yes."

**This was confirmed with an EVP that was caught at the same time this occurred. See the EVP labeled “Yes” on the supplied evidence CD.**

## **Ryan's Personal Experience/Corona Case/August 2nd, 2008**

It was about 11pm at night and Mike and myself were upstairs turning off all the lights and closing the blinds. We were in the middle room of the upstairs and all the lights were off except we noticed that the ceiling fan was on. Mike was standing by the master bedroom door and I went to turn off the fan. Right when I clicked it off the touch activated lamp turned on by itself. We tried a few things to recreate this phenomena but were not successful.

## **HBs Personal Experience/Corona Case/August 2nd, 2008**

### Technical Investigation

The house electrical system was examined to determine electro-magnetic properties and for functioning inside normal parameters.

OF NOTE: The local area high voltage transformer for the block is located on an easement directly north/west of the property. It is a standard 75kva, however the number of houses served is unknown. It is my professional opinion that the high voltage transformer is operating at over capacity at peak usage periods as the electro-magnetic field level and transformer core temperature are outside of normal operational parameters.

The house main and sub panels were opened and examined. They were found to be assembled and wired to code and there were no visible or metered issues. Electrical ground potential was measured to a cold water pipe and was found to be well inside acceptable parameters.

All electrical outlets and switches measured during peak usage time exhibited a large amount of the EMF from the high voltage transformer. After the peak usage period the EMF was diminished to barely detectable levels, which indicate proper house wiring.

### Personal Investigation Notes

While performing an unaccompanied technical walk through of the house to check camera and meter placement prior to the onset of the formal investigation period I entered the room labeled "boys room" and immediately felt a presence. I discussed this with Troy and we performed a complete investigation of the room during the formal investigation period. There were several trifield alerts but no significant contact or K2 readings. As of this report I have not reviewed the EVP report for this room.


Further investigations to include the garage with Troy, and a solo investigation of the back yard and side areas of the house. No significant events were observed or recorded.
